

ARTICLES OF INCORPORATION OF LHS COMMUNICATIONS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of this corporation is LHS Communications, Inc. The principal place of business is 6919 Pensacola Blvd., Pensacola, Florida 32505.

ARTICLE II DURATION

The duration of this corporation is perpetual.

ARTICLE III PURPOSE
