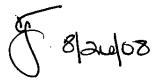

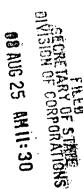

ARTICLE I.

NAME

The name of this corporation is Patients 1^{st} Homecare Solutions, Inc.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of August 21, 2008.

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

CAPITAL STOCK
