ARTICLES OF INCORPORATION

OF

VIVA VERO, INC.



The undersigned, desiring to form a stock corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, sets forth the following:

ARTICLE I

NAME

The name of the corporation shall be: VIVA Vero, Inc. (hereafter, the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The principal place of business of the Corporation shall be 955 37th Place, Vero Beach, Florida 32960.

ARTICLE III

PURPOSES
