ARTICLES OF INCORPORATION

OF

CHRISTINA'S PIZZERIA & WING CO.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Christina's Pizzeria & Wing Co.

ARTICLE II

The existence of the corporation shall begin on August 26, 2008.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 3320 Moog Road, Holiday, Florida 34691.

The maximum number of shares this Corporation is authorized to issue is 5000, all of which shall be Common Shares.
