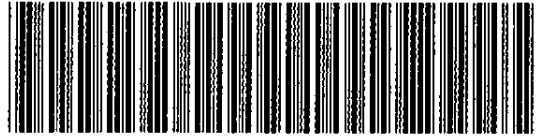

NAME**
