1. NAME

The name of this corporation is:



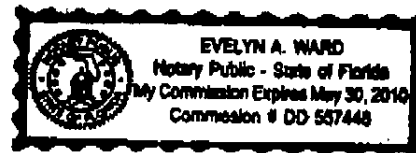
