**ARTICLES OF INCORPORATION
OF**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **Scott's Screens of South Florida, Inc.**

ARTICLE II

The existence of the corporation shall begin on August 29, 2008.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 4117 Gardner Drive, Port Charlotte, Florida 33952.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. 
