ARTICLE I

NAME

The name of this corporation is "MEDROUNDS, INC.".

ARTICLE II

NATURE OF BUSINESS

ARTICLE V

PRINCIPAL OFFICE OF THE CORPORATION

The principal street address and mailing address of the corporation shall be 841 Suntree Woods Drive, Melbourne, Florida 32940. The Board of directors may, from time to time, change the principal office and mailing address to any other address in Florida.

ARTICLE VI

AMENDMENTS






