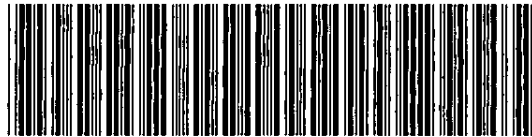

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I:
NAME

The name of the Corporation is: MANIS ENTERPRISES, Inc. The Principal place of business of this corporation shall be 2514 Georgia Avenue, St. Cloud, Florida 34769. The mailing address of the Corporation shall be 2514 Georgia Avenue, St. Cloud, Florida 34769.

ARTICLE II:
DURATION

The duration of the Corporation is perpetual.

ARTICLE III:
PURPOSE

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
