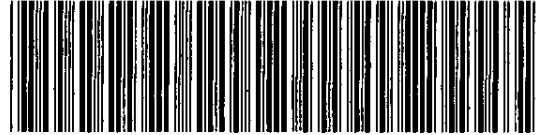

**ARTICLES OF INCORPORATION
OF
ETCHEBERRY, INC.**

The undersigned, intending to form and create a corporation under the Florida Business Corporation Act, does hereby state and certify the following:

**ARTICLE I
NAME**

The name and address of the sole incorporator is Lisa A. Etcheberry, 5415 Saddlebrook Way, Wesley Chapel, FL 33543.

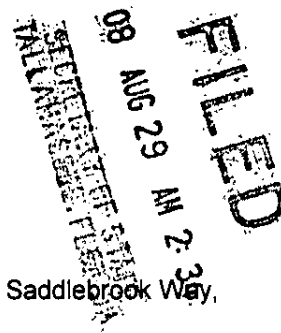
**ARTICLE VI

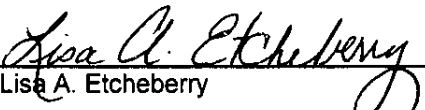

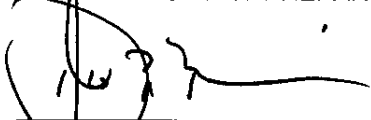
