ARTICLES OF INCORPORATION

The undersigned, a natural person competent to contract, acting as incorporator of a corporation (hereinafter referred to as the "Corporation") under the provisions of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE 1.
Name

i.1) Name. The name of the corporation is Yogalicious, Inc.

ARTICLE 2. Nature of Business

2.1) <u>Nature of Business</u>. The specific use of the business is to be transacted by this Corporation is to engage in Yoga/Dance/Creative Movement instruction in the form of workshops and classes.

ARTICLE 3. Capital Stock

- 3.1) Number of Authorized Shares. The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of Common Stock, having a par value of \$\infty\$. \$1.00 per share.
- 3.2) Right and Method of Voting. At every meeting of the stockholders, every holder of the Common Stock of the Corporation shall be entitled to one (1) vote for each share of Common Stock standing in his name on the books of the Corporation. At each election for Directors, every holder of the Common Stock of the Corporation shall have the right to vote, in person or by proxy, the number of shares owned by him for as many persons as there are Directors to be elected and for whose election he has a right to vote, or to cumulate its votes by giving one

candidate as many votes as the number of such Directors multiplied by the number of its shares shall equal, or by distributing such votes on the same principal among any number of such candidates.

- 3.3) Payment for Shares. The consideration for the issuance of the Common Stock of the Corporation may be paid, in whole or in part, in money or other property, tangible or intangible, or in labor or services actually performed for the Corporation. When payment for the consideration for which such shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and non-assessable. Neither promissory notes nor future services shall constitute payment or part-payment for such shares Corporation. In the absence of fraud in the transaction, the judgment of the Board of Directors or the stockholders, as the case may be, as to the value of the consideration received for such shares shall be conclusive.
- 3.4) <u>Dividends</u>. The holders from time to time of Common Stock of the Corporation shall be entitled to receive, when and as declared by the Board of Directors, from the net earnings or from the surplus of the assets over the liabilities, including capital, of the Corporation, but not otherwise, dividends payable either in cash, in property, or in shares of the Common Stock of the Corporation.

ARTICLE 4. Period of Duration

4.1) Period of Duration. The period of duration of the Corporation is perpetual.

ARTICLE 5. Registered Agent and Address

5.1) Address. The initial business address of the Corporation in the State of Florida is 1908 Applegate Cove, Casselberry, Florida 32707. The Board of Directors may, from time to time, move the principal office to any other address in Florida, upon giving notice, if required, to the Florida Secretary of State.

5.2) Registered Agent. The registered Agent of the Corporation shall be Lori Wellen, whose business office is 1908 Applegate Cove, Casselberry, Florida 32707

ARTICLE 6. Data Respecting Directors

- 6.1) Initial Board of Driectors. The initial Board of Directors shall consist of one (1) member. The initial Board of Directors shall hold the organizational meeting of the corporation.
- 6.2) Names and Addresses. The name and address of the initial members to the Board of Directors, who shall serve until the first annual meeting of stockholders or until successors shall have been elected and qualified are:

6.3) Increase or Decrease of Directors. The number of Directors may be increased or decreased from time to time, by amendment of the Bylaws. The number of Directors shall never be less than one (1).

ARTICLE 8.

Provisions for Regulation of the Internal

Affairs of the Corporation

8.1) Bylaws. The initial Bylaws of the Corporation shall be adopted by the Board of Directors. The power to amend, alter or repeal the Bylaws, or to adopt new Bylaws, shall be vested in the Board of Directors. The Bylaws may contain any provisions for the regulation and management of the affairs of the Corporation not inconsistent with the provisions of Chapter 607 of the Florida Statutes or other law, or these Articles of Incorporation.

ARTICLE 9. Amendments

9.1) Amendments to Articles of Incorporation. The Corporation reserves the right, from time to time, to amend, after or repeal, or to add any provision to its Articles of Incorporation, in any manner now or hereafter prescribed or permitted by the provisions of any other applicable Statue of the State of Florida and all rights conferred upon stockholders by these Articles of Incorporation, or any other amendment hereto, subject to this reservation.
