

The undersigned subscribers, ALVIN D. BAILEY and JANET L. BAILEY, each a natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE. Name.

The name of the corporation is FULL SERVICE CONSTRUCTION, INC. The business address of the corporation is 23245 Harborview Road, Unit B, Port Charlotte, Florida 33980.

ARTICLE TWO. Nature of Business.

The general business to be transacted by this corporation is as follows:


