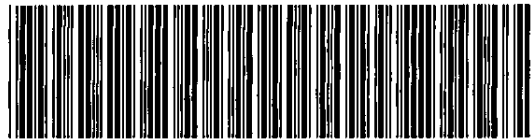

Attached is a Certificate of Domestication along with an Articles of Incorporation with a check in the amount of \$128.75.



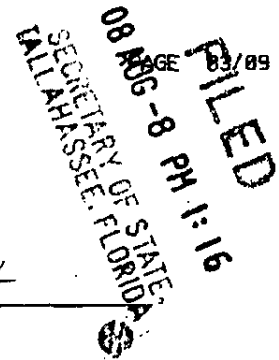
