
ARTICLE X - INCORPORATOR

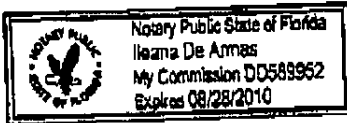
