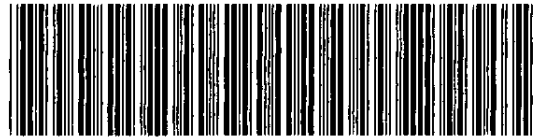

ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this corporation is THOMAS TRUNCALE, P. A..

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSE

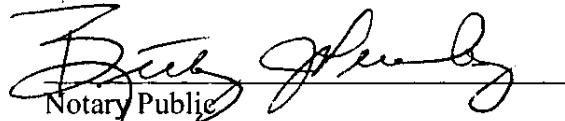

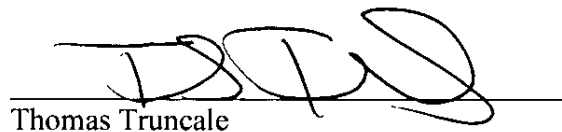
