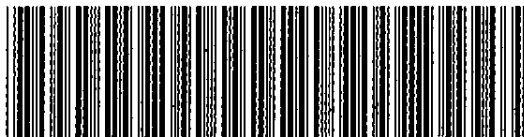

ARTICLES OF INCORPORATION

OF

SAI TECK, INC

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is: SAI TECK, INC.

ARTICLE II - NATURE OF BUSINESS

The Corporation is to provide consulting and computer services and related activities to the public and to businesses.

ARTICLE III - CAPITAL STOCK

The authorized capital stock of the Corporation shall be 1000 shares of common stock at a par value of \$1.00 per share. The issued stock will be 100 shares of common stock at a value of \$1.00 per share as the initial stock.

ARTICLE IV - TERM OF EXISTENCE

This Corporation is to exist perpetually.


ARTICLE XII - AMENDMENT
