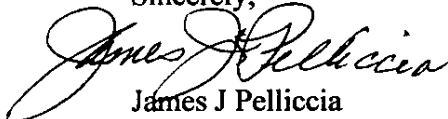

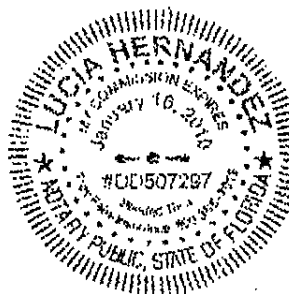

He had already given me his cell phone number and I was to give him a call that he may be able to use me to transport cars from the auctions to his car lot. I called to tell him that I was terminated and that he could come to my home if he needed a hair cut, at that point he told me to meet him at ABC Auction on Fri May 26th 2008.

STATEMENT (Continued)

I drove a car to Don's Cars at 700 Clay Street, Winter Park, FL. I was doing this several days a week until he asked me if I wanted to go to dealer license school so he could set me up with a dealers license in my name. I completed the school and at that point he applied for a dealers license in the name of Auto Specialists at Central Florida Inc. He also incorporated that incorporating me the president, vp, secy, treasurer.

While waiting for the license to be approved by DMV he had me enter into an agreement with Don's Cars Inc. owned by him with no dealers license also operating under Ed Fawcett Motors dealers license number. I agreed to loan Don's cars inc. \$75000.00 by use of my personal credit line (see loan agreement). On September 30, 2008 DMV issued Dealers License #V1022470/1 to Auto Specialist of Central Florida Inc. in my name. At this point he wanted to move from 700 Clay St and away from Ed Fawcett to 1786 SR 436, Winter Park, FL. He forged my name to a lease Compass Realty of Winter Park. During all this time he was buying and selling cars. I obtained floor plans and credit lines with car auctions under the name of Auto Specialists. He obtained numerous credit cards business and personal in my name and auto specialists (mostly internet applications). He had these cards sent to his home address at 1240 Majestic Oaks Dr. Apopka, FL 32712. He also opened numerous checking accounts (see statements) and forged my name to an auto loan at Fifth Third Bank and had it notarized and did not pay for the auto from the auction. That vehicle was repossessed by Dealer Services Corp. leaving me responsible to pay the bank. In January due to my heart condition I was hospitalized at that time he told me to stay home he would operate the car lot.

On or about the second week of March the landlord (Compass Realty) locked us out of the building at 1786 SR 436 for non payment of rent and the fact the this location was not properly zoned for a car lot. Also I started to receive phone calls from creditors about past due payments on credit that I did not know of. Also I received calls from Dealer Services Corp and auctions about cars the he purchased and did not pay for and in turn sold these cars to individuals. Some sales were involved with EBAY Motors on the internet.

As of this date the estimated amount of loss to me appears to be in the range of \$500,000.00 for forgery, embezzlement, fraud and identity theft.

On May 30th 2009 I filed a police report with Winter Park Police Department Case# 09-9267.
