ARTICLE I NAME

The name of the corporation is:

ARTICLE II NATURE OF CORPORATE BUSINESS

To own, operate, and maintain a transportation and delivery business for the transportation of passengers, freight, mail, express baggage, goods, ware, merchandise, and other property of every kind and nature, and to conduct, engage in, and carry on the business of transportation of property of every class and description.
