

ARTICLES OF INCORPORATION OF TROY ELIZABETH BROTHERS, M. D. P.A.



FIRST: The name of the corporation (the "Corporation") is:

TROY ELIZABETH BROTHERS, M. D. P.A.

The purpose for which this corporation is formed is to allow the licensee to conduct all business authorized and lawful for the licensee under Chapter 458 (MEDICAL PRACTICE) of the Florida Statutes through this entity.
