



ARTICLES OF INCORPORATION

OF

ARTICLE I, CORPORATE NAME

The name for this corporation is CREATIVE SOLUTIONS BEHAVIORAL HEALTH, INC., and has its principal place of business at 94 San Blas Ave. Kissimmee, FL 34743.
