ARTICLES OF INCORPORATION

OF

VANESSA RASHID, DMD, P.A.

THE UNDERSIGNED, acting as sole incorporator of a professional corporation to be formed under the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes §621.01 et seq., adopts the following Articles of Incorporation:

ARTICLE I

CORPORATE NAME

The name of the corporation is: VANESSA RASHID, DMD, P.A. (the "Corporation").

ARTICLE II

PRINCIPAL OFFICE/MAILING ADDRESS

The initial principal office and mailing address of the Corporation is 5683 Whispering Willow Way, Fort Myers, Florida 33908.

ARTICLE III

CAPITAL STOCK

The aggregate number of shares that the Corporation is authorized to issue is One Thousand (1,000) shares of common stock, and the par value of each such share shall be One Cent (\$0.01). Par value shall have no effect on the Corporation's capital structure.

ARTICLE IV

INITIAL REGISTERED AGENT AND STREET ADDRESS

The street address of the initial registered office of the Corporation is 5683 Whispering Willow Way, Fort Myers, Florida 33908 and the name of the Corporation's initial registered agent at such address is Andrew Rashid.

ARTICLE V

INCORPORATOR

The name and address of the sole incorporator of the Corporation is Vanessa Rashid, 5683 Whispering Willow Way, Fort Myers, Florida 33908.

ARTICLE VI**INITIAL DIRECTOR**

The number of directors constituting the initial Board of Directors of the Corporation is One (1). The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than One (1). The name and address of the person to serve as the sole director of the Corporation until the first annual meeting of the shareholders of the Corporation, or until one or more successors have been elected and qualify, is as follows:

ARTICLE VII**PURPOSE**

The general purposes for which this Corporation is organized shall be to render dentistry services to the general public under a license, and to do all things in connection therewith that are customarily performed by a licensed dentist under the laws of the State of Florida. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Service Corporation and Limited Liability Company Act.

No one other than an individual who is duly licensed or legally authorized to practice dentistry in the State of Florida may own stock of this Corporation. No shareholder of this Corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock. Any shareholder who becomes legally disqualified to practice dentistry shall sever all employment with and financial interest in the Corporation. No shareholder of the Corporation may sell or transfer his stock in this Corporation, except to a professional corporation, a professional limited liability company, or an individual who is eligible to be a shareholder of the Corporation under the laws of the State of Florida.

ARTICLE VIII**DURATION**

The duration of the Corporation is perpetual commencing upon the filing of these Articles of Incorporation with the Secretary of State of Florida.

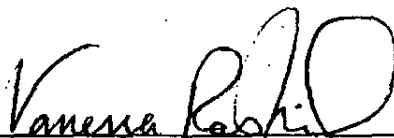
