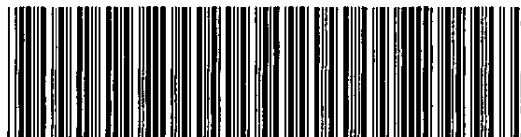

ARTICLE I - NAME

The name of this Corporation is Ascend Conditioning, Inc.; the mailing address is 501 St. Michelle Way, Margate, Florida 33068.




