TO THE
ARTICLES OF INCORPORATION

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned, being the Chief Executive Officer of THE SPINE NETWORK, INC., a Florida corporation (the "Corporation"), bearing Document Number P08000084895, does hereby submit these Articles of Amendment for the purpose of amending the Corporation's Articles of Incorporation as follows:

FIRST: Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety and replaced with the following:

ARTICLE I - NAME

The name of this corporation is **Pure Healthy Back, Inc.**
