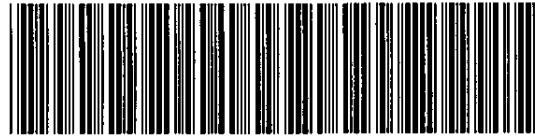

ARTICLES OF INCORPORATION
OF

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I

The name of the corporation is "Floridians for Industry, Jobs and Growth Electioneering Communications Organization, Inc." The mailing address of the corporation is: Post Office Box 6765, Lakeland, Florida 33807-6765. The street address is 6700 South Florida Avenue, #25, Lakeland, Florida 33813.

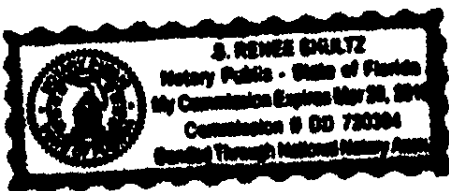
