## **ARTICLES OF INCORPORATION OF Asante Air, Inc.**

*The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

### **ARTICLE I - NAME**

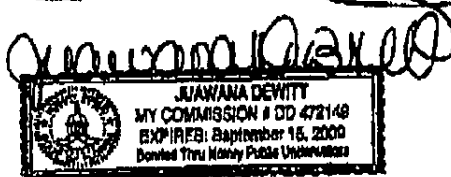
