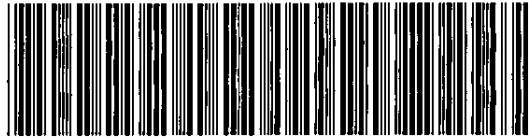

ARTICLE VI


The corporation shall indemnify its directors and officers to the fullest extent permitted by law.

The corporation shall exist perpetually, commencing as of September 15, 2008.


