ARTICLES OF INCORPORATION OF ED & SON SECURITY SYSTEMS, INC

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation right privileges, immunities, and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

The amount of capital with which its corporation may begin doing business shall be not less than five hundred dollars (\$ 500.00).
