Name



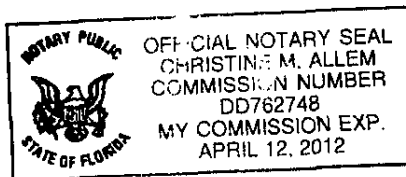

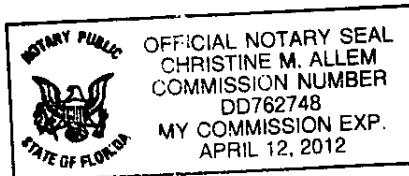
