ARTICLES OF INCORPORATION

OF

VYVARY, INC.



The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Vyvary, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 4037 Metric Drive, Suite 600, Winter Park, Florida 32792. The mailing address of the Corporation shall be Post Office Box 2402, Goldenrod, Florida 37733-2402.

ARTICLE III - CAPITAL STOCK
