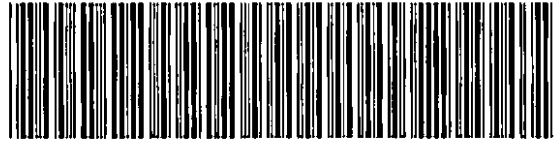

FIRST: The Articles of Incorporation were filed on September 24, 2008. The Document Number for this entity is P08000087594.

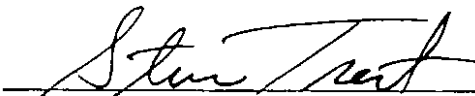
SECOND: The corporation amends its Articles of Incorporation to change its name to:
