ARTICLES OF INCORPORATION OF Clay Owens Construction, Inc.

The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: Clay Owens Construction, Inc.
