**ARTICLES OF INCORPORATION
CVP TRADING CORP.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a corporation.

ARTICLE I

The name of the corporation ("Corporation") is CVP Trading Corp.

ARTICLE II

The existence of the corporation shall begin on the date of filing of these articles.

ARTICLE III

The street and mailing address of the principal office of the Corporation is 3001 Southwest 3rd Avenue, Miami, Florida 33129.
