ARTICLES OF INCORPORATION

OF

The undersigned incorporator, being a natural person over the age of (18) years hereby makes, subscribes, acknowledges, executes and files with the Department of State these ARTICLES OF INCORPORATION for the purpose of forming a Corporation for profit in accordance with the laws of the State of Florida.

Article 1...Name
