ARTICLES OF INCORPORATION

The undersigned incorporator hereby certifies to the following in order to form a corporation for a profit under the laws of the State of Florida.

<u>ARTICLE I - NAME</u>

The name of this corporation is, AXIOM APPRAISALS, INC.
