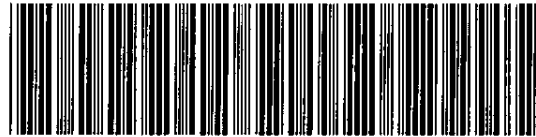

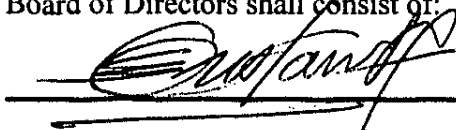
ARTICLE VII- SELF DEALING

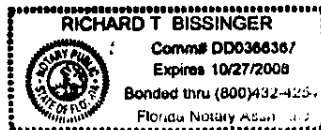
