

The undersigned, for the purpose of forming a corporation under and subject to the "Florida Business Corporation Act", hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation is **TOO MUCH TEES, INC.**



The aforesaid Corporation shall commence and be effective on the date and at the time of filing these Articles of Incorporation with the Department of State of the State of Florida.






