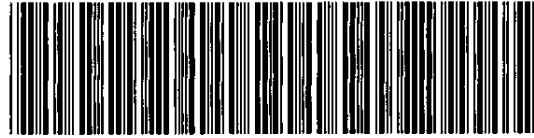

ARTICLE I - NAME AND PRINCIPAL ADDRESS

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The name of the corporation is RADIOGRAPHIC, INC., and the principal address and principal place of business is 10430 66TH STREET, UNIT 1D, PINELLAS PARK, FLORIDA 33781.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o O'CONNOR & ASSOCIATES, 1250 S. Belcher Road, Suite 160, in the City of Largo, County of Pinellas, Florida 33771. The name of its registered agent at such address is PATRICK M. O'CONNOR, ESQUIRE.
