## ARTICLES OF INCORPORATION OF Miro Dental & Med Sps Corp., a Florida Corporation

WE, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

#### **ARTICLE!**

The name of this corporation shall be:

#### Miro Dental & Med Spa Corp, a Florida Corporation

Its business shall be carried on in Miami, Florida and at such other point or places in the State of Florida, and in the United States and foreign countries as may from time to time be authorized by the Board of Directors. Its principal office shall be at 564 8.W. 42<sup>nd</sup> Avenue, Second Floor, Miami, Florida 33134.

This general nature of business to be transacted is as follows:

<u>SECTION 1.</u> To purchase, lesse, hire or otherwise acquire rasi and personal property, improved and unimproved, of every kind and description, and to sell, dispose of, lesse, convey, ancumber, and mortgage said property, or any part thereof. To acquire, hold, lease, manage, operate, develop, control, build, erect, maintain, for the purposes of the company, construct, reconstruct or purchase, either directly or through ownership in atock in any corporation, any lands, buildings, offices, stores, warehouses, mills, ship, factories, plants, gas houses, machinery rights, easements, privileges, franchises and licenses, and to sell, lesse, hire or otherwise dispose of the lands, buildings or other property of the company or any part thereof.

SECTION 2. To act as agent for others in the purchase and sale of goods, wares, merchandise, articles, materials and equipment of all kinds and as act as a mortgage brokerage firm and/or business.

SECTION 3. To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, assign, sell, transfer, otherwise dispose of, and to invent in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description, exceptible if

not to conduct a banking, safe deposit, trust, insurance, suraty, express railroad, canal, talegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

SECTION 4. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida and in all other states and countries.

SECTIONS. To contract debts and borrow money, issue and self or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness, as required.

<u>SECTION 6.</u> To purchase the corporate assets of any other corporation and engage in the same or other character of business.

SECTION 7. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pleage, or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other state or government, and white owner of such stock, to exercise all rights, powers, and privileges of ownership, including the right to vote such stock.
