ARTICLES OF INCORPORATION OF FLORIDA PRO-TECH CONSTRUCTION, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

FLORIDA PRO-TECH CONSTRUCTION, INC.

ARTICLE II Principal Office and Mailing Address

The address of the principal office and the mailing address of this corporation shall be:

ARTICLE III Business and Purposes

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

ARTICLE IV Capital Stock

- (a) The aggregate number of shares of capital stock authorized to be issued by this corporation shall be **Ten Thousand (10,000)** shares of common stock with a par value of **One Dollar (\$1.00)** per share.
