ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HOME AWAY FROM HOME WELLINGTON LEARNING CENTER, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to the Articles of Incorporation:

- 1. The name of the Corporation is HOME AWAY FROM HOME WELLINGTON LEARNING CENTER, INC.
- 2. Article IV of the Articles of Incorporation of the Corporation is hereby amended in its entirety to provide as follows:

"Article IV

The Corporation shall be authorized to issue: (a) Ten Thousand (10,000) shares of voting common stock having a par value of One Dollar (\$1.00) per share; and (b) Ten Thousand (10,000) shares of non-voting common stock having a par value of One Dollar (\$1.00)

Non-voting common stock: (a) shall be non-redeemable by the Corporation; (b) shall not be convertible by the shareholder owning same; (c) shall enjoy no preference rights in the payment of dividends, distributions or other amounts; and (d) shall enjoy no voting rights (except as specifically required by the Florida Business Corporation Act).

There shall be no distinction between voting and non-voting common stock, other than as to voting rights."

3. The Articles of Incorporation of the Corporation are further amended to provide new Articles, Article VIII and Article IX which Articles provide as follows:

"Article VIII

These Articles of Incorporation, as amended, shall not be further amended or restated except by the unanimous written consent of the shareholders owning all of the voting and non-voting common stock of the Corporation.

Article IX

The shareholders of the Corporation are parties to a certain Stock Option and Shareholders Agreement entered into on the 23rd day of February, 2016."
