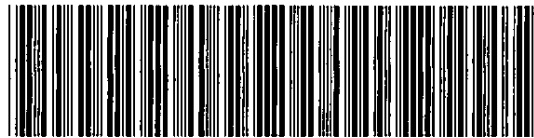

The name of this corporation is BAKER GUNS & GOLD PAWN, INC

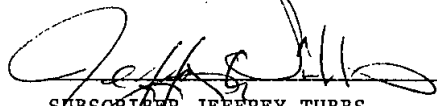

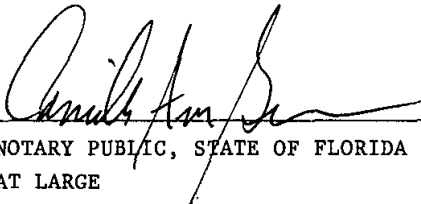
