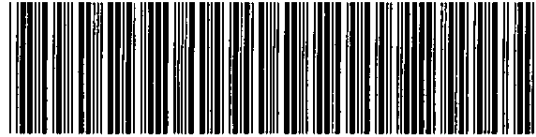

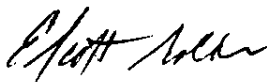

The name of this corporation is The Civil Group, Inc.

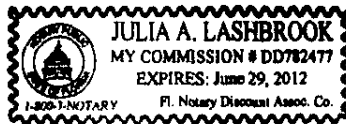
