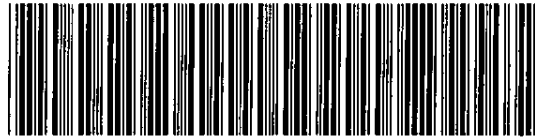

**ARTICLE I. CORPORATE NAME**



#### ARTICLE IX. AMENDMENT




### DESIGNATION AND ACCEPTANCE OF REGISTERED AGENT
