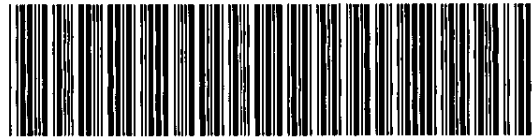

ARTICLES OF INCORPORATION.

OF

ARTICLE I: NAME

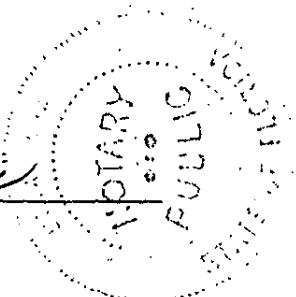
