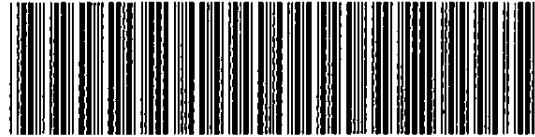

**ARTICLES OF INCORPORATION
OF

Article ONE.

NAME AND LOCATION OF PRINCIPAL OFFICE

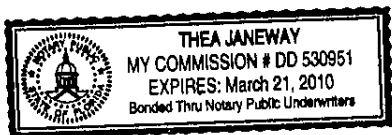
