## ARTICLES OF INCORPORATION OF GREGORY A. CISNEROS, M.D., P.A.

TALLAHASSEE, FLORID:

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

#### Article I. Corporate Name

The name of this corporation is Gregory A. Cisneros, M.D., P.A.

#### Article II. Duration

The corporation shall have an immediate effective date upon the filing of these Articles with the Florida Department of State.

# Article III. Purpose

The corporation is organized for the specific purpose of offering medical services by a licensed physician. The corporation shall have and may exercise all the rights, powers and privileges now or hereafter conferred upon corporations organized under the laws of Florida as a professional service corporation.

### Article IV. Capital Stock

The corporation is authorized to issue Five Hundred (500) shares of stock, all of which shall be voting common shares with a par value of \$1.00 (one dollar). All stock when issued shall be fully paid for and shall be nonassessable. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. Shares shall only be issued to a party who qualifies to be a shareholder under the terms of Fla. Stat. sec. 621.11.

# Article V. Designation of Registered Agent and Office

The name of the initial registered agent of the corporation is Gregory A. Cisneros. The street address of the initial registered office of the corporation is 33 Old Kings Road North, Suite 2, Palm Coast, FL 32137.

# Article VI. Principal Office and Mailing Address

The principal place of business and mailing address of the corporation are both: 33 Old Kings Road North, Suite 2, Palm Coast, FL 32137.

# Article VII. Initial Board of Directors

The corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time as provided in the Bylaws of the corporation, but shall never be less than one. Directors need not be stockholders in the corporation. The name and address of the initial Board of Directors who shall hold office until the first annual meeting of shareholders of the corporation or until his successors are duly elected and qualified are as follows:
