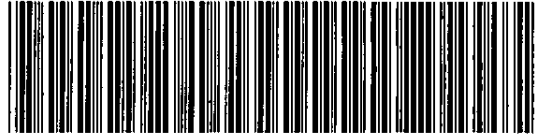

The undersigned, being duly licensed to practice law in the State of Florida, desiring to form a corporation in accordance with Chapter 607 of the Florida General Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

- 1.01 The name of the Corporation shall be SHINE PROMOTIONS, INC..

**ARTICLE TWO
PRINCIPAL OFFICE**

- 2.01 The location and address of the Corporation's initial principal office in Florida is 2741 SW 149th Place, Miami, FL 33185.

**ARTICLE THREE



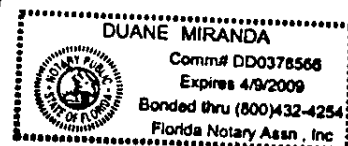


