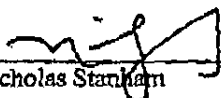
INDEMNIFICATION

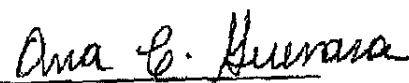

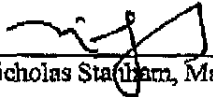
