Dear Ms. Bauer:


Let this letter serve as our assurance that there is no intent on our part or that our client to deceive or defraud you or anyone else relying upon system to determine whether Lee's Miami Marine Service, Inc. is an active corporation. As we advise you during our conversation, our client, Mr. Vu Nguyen Le, did not want to reinstate this old corporation. He wanted to renew the trademark of the new corporation, Lee's Miami Marine Service, Inc., which is the succeeding corporation of the former.

We want the FDOS to correct the problem by fulfilling the request which we indicated in our email. Cancel out the reinstatement and renew the trademark for Lee's Miami Marine Service, Inc. for 2011. The balance from the transaction (i.e. should be credited back to Mr. Le's credit card). We do not know whether his bank initiated any credit activity, but he did advised them about the error and we do believe that they indicated that they would issue a temporary credit while an investigation is undertaken.
