ARTICLES OF INCORPORATION  
OF  
TRAINING UP A CHILD, INC.  
A Florida Profit Corporation

ARTICLE I - NAME

The name of this Corporation is TRAINING UP A CHILD, INC. The mailing address is 5907 NW 65<sup>th</sup> Street, Ocala, Florida 34482.

ARTICLE II - DURATION

The period of duration of the Corporation is perpetual.

ARTICLE X – INDEMNIFICATION


The Corporation shall indemnify any officer, director or employee, or any former officer, director or employee, to the fullest extent permitted by law.
